1. Policy Statement

TCF can be defined as a regulatory framework set by the Financial Sector Conduct Authority (FSCA). This framework governs the way TICKMILL SOUTH AFRICA (PTY) LTD and its representatives conduct daily dealings with clients, ensuring all clients are treated fairly during all stages of the product life-cycle and advice process.

TICKMILL SOUTH AFRICA (PTY) LTD ensures clients are at the very heart of all that we do. We are fully committed to providing the highest standards of client service and advice.

Our customers are our most valuable asset and our aim is to ensure we deliver a user-friendly, robust, reliable and cost-effective financial service. As part of our overall approach we are fully committed to treating our clients fairly and as such we endeavour to meet their expectations of high quality service.

Our Treating Customers Fairly (TCF) policy is centred around the guidance provided by the Financial Sector Conduct Authority (FSCA) and our External Compliance Officers, to ensure we consistently deliver fair outcomes to our clients and take responsibility for the firm and staff (at all levels) providing an enhanced service quality to clients, based on a culture of openness and transparency. As a firm, we take the requirements of the FSCA seriously, in particular, the requirement to treat customers (clients) fairly.

The FSCA has outlined six key outcomes, which are central to the TCF initiative:

Outcome	Description
Outcome 1	Customers are confident that they are dealing with firms where the fair treatment of customers is central to the firm culture.
Outcome 2	Products and services marketed and sold in the retail market are designed to meet the needs of identified customer groups and are targeted accordingly.
Outcome 3	Customers are given clear information and are kept appropriately informed before, during and after the time of contracting.
Outcome 4	Where customers receive advice, the advice is suitable and takes account of their circumstances.
Outcome 5	Customers are provided with products that perform as firms have led them to expect, and the associated service is both of an acceptable standard and what they have been led to expect.
Outcome 6	Customers do not face unreasonable post-sale barriers to change product, switch provider, submit a claim or make a complaint.

2. Our Service

We ascertain the appropriateness of the requested service for all new clients prior to accepting an instruction, ensuring it is in line with their knowledge and experience.

We continually aim to understand the needs of our clients.

We keep our clients fully informed in a clear and fair manner that is unambiguous and not misleading.

We ensure our services are delivered with clarity and transparency and do not contain hidden conditions or rely on complex technical definitions.

We make certain our clients understand the risks associated with our services at the outset of an instruction.

We work hard to ensure that service and risk information remains clear and prominent at all times.

In the event that there is a conflict of interest, we will inform our clients as soon as possible once we become aware of it.

Where required by applicable regulation, we also assess the appropriateness of our products and services for prospective clients. We refer to this assessment throughout the onboarding process to help ensure clients understand the nature, risks and characteristics of the products offered. This promotes an open, transparent and interactive onboarding process and supports informed client decision-making.

TICKMILL SOUTH AFRICA (PTY) LTD provides ongoing training to employees regarding regulatory requirements, product governance, client communications, complaints handling, market conduct obligations and Treating Customers Fairly principles

An important part of our client service offering is ongoing support. We are committed to ensuring that clients receive clear information, appropriate assistance and timely support throughout their relationship

with the Company. Clients may communicate directly with us regarding their accounts, products, services and any concerns they may have.

4. Complaints

We respond in a timely manner to our customers' and prospective customers' questions and queries, and address any issues or concerns promptly. All customer complaints, if presented via the Complaints procedure detailed in the Complaints Policy, are dealt with and escalated as appropriate and as required by us in order to meet our obligations to our clients, our regulator and the Ombud.

Our policy is in line with the current guidance from the FSCA and is in line with the principles of the FSCA that "a firm must pay due regard to the interests of its customers and treat them fairly".

TICKMILL SOUTH AFRICA (PTY) LTD further recognises its obligation to demonstrate to the FSCA that it adheres to TCF principles. Documenting the implementation of new business processes or changes to existing practices is therefore a fundamental part of our TCF journey.
